#### Preliminary

#### Short Title

1. This notice may be cited as the *Public Service Departmental Arrangements Notice (No.3) 2026*.

#### Commencement

2. This notice is taken to have commenced on 1 July 2026.

#### Authority and purpose

3. This notice is made under sections 197 and 198 of the *Public Sector Act 2022*.

#### Part A – Establishment and declaration of government entities

4. Each part of the department of government listed in Column 1 of the Schedule is established as a government entity and declared to be part of the department listed in Column 2 of the Schedule.

#### Part B – Government entities amalgamated with, and declared to be part of, a department

5. The government entities established under clause 4 of this notice listed in Column 1 of the Schedule are amalgamated with, and declared to be part of, the department of government listed in Column 3 of the Schedule.
